LETF RESOLUTION 21-169

A RESOLUTION OF THE CITY OF PANAMA CITY BEACH, FLORIDA, SITTING AS THE LAW ENFORCEMENT TRUST FUND BOARD; AUTHORIZING EXPENDITURES FROM THE LAW ENFORCEMENT TRUST FUND FOR A DONATION TO PANHANDLE CRIME STOPPERS, INC. IN THE AMOUNT OF \$1,000.

WHEREAS, the Law Enforcement Trust Fund is a special fund that can only be used for purposes designated by Section 932.7055(5)(a), Florida Statutes, such as crime prevention, safe neighborhoods, protracted investigations, technical equipment and community relations programs; and

WHEREAS, the City, as a local law enforcement agency that acquires at least \$15,000 in its LETF pursuant to the Florida Contraband Forfeiture Act within a fiscal year, must expend or donate no less than 25% of such proceeds; and

WHEREAS, the police department recommends a portion of the funds be donated to Panhandle Crime Stoppers, Inc., and the City finds that the use of funds for this purpose complies with the requirements of Section 932.7055(5), Florida Statutes.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Panama City Beach, sitting as the Law Enforcement Trust Fund Board, that the appropriate officers of the City are authorized to appropriate funds from the City's LETF for a donation to Panhandle Crime Stoppers, Inc., in the amount of One Thousand Dollars (\$1,000.00).

THIS RESOLUTION shall be effective immediately upon passage.
