

RESOLUTION 21-215

A RESOLUTION OF THE CITY OF PANAMA CITY BEACH, FLORIDA, RATIFYING AND APPROVING AN AGREEMENT WITH WISE SERVICES, INC. FOR THE EMERGENCY PURCHASE OF POWER FEEDER CABLE REPLACEMENT FOR THE CITY'S WASTEWATER TREATMENT SYSTEM IN THE NOT TO EXCEED AMOUNT OF \$65,000.

WHEREAS, on Monday, August 16, 2021 Tropical Storm Fred made landfall near the City of Panama City Beach; and

WHEREAS, on August 13, 2021, Governor Ron DeSantis declared a state of emergency in Bay County related to the dangers presented by Tropical Storm Fred; and

WHEREAS, as a result of Tropical Storm Fred a power transformer near the City's effluent pump station caught fire and was destroyed which severely damaged the cabling and conduit providing power to the effluent pump station; and

WHEREAS, the City finds that the loss of power to the pump station places a risk to the public health, safety and welfare constituting an emergency for the purposes of Section 5-7(h) of the City Charter; and

WHEREAS, the City finds that three competitive quotes were achieved to satisfy the City's emergency procurement procedures and that ratification of this purchase was necessary to prevent further risk to the public health, safety, and welfare.

NOW, THEREFORE BE IT RESOLVED that the appropriate officers of the City are authorized to accept and deliver on behalf of the City that certain Agreement between the City and Wise Services, Inc., relating to the emergency repairs and replacement of the power feeder cables for the City's Wastewater Treatment System, in the not to exceed amount of Sixty Five Thousand Dollars (\$65,000), in substantially the form attached and presented to the Council today, with such changes, insertions or omissions as may be approved by the City Manager and whose execution shall be conclusive evidence of such approval.

THIS RESOLUTION shall be effective immediately upon passage.

Job Name / Location: Panama City Beach WWTP. (Woodlands Pumping Station Feeder)

We hereby submit a proposal to do the following:

Supply labor, materials and equipment to replace approx. 1800' of 600mcm feeder cables and 750' of 3/0 neutral wire. Replace (8) runs of 4" conduit under transformer that got melted from fire. Amount of conduit that needs replacing is unknown at this time. Replace conduit and wire that feeds CT-Meter base. Terminate cables and check out. Remove damaged materials from job site. The job should be completed in approx. 3 days from notice to proceed. 1st day will be demo of existing melted feeder cables and fix any conduit that's compromised. We will get a wire length the first day and get it ordered. If I get the wire lengths called in to my supplier by 10:00am, I will get it the next day. 2nd day we will pick up wire and start pulling in new conductors. Should have it all pulled on day #2. Day #3 will consist of testing cables and terminating. We will use life saver cables the are colored the appropriate phases. If I started Monday 8-23-2021 I will be done and back online by 4:00pm on Wednesday 8-25-2021.

We propose to do the above referenced work for the sum of:
