### ORDINANCE NO. 1577

AN ORDINANCE EXCLUDING FROM THE CITY OF PANAMA CITY BEACH, FLORIDA, THE FOLLOWING VOLUNTARILY ANNEXED **PARCELS** WHICH CONTIGUOUS TO UNINCORPORATED AREA OF BAY COUNTY, FLORIDA, UPON PETITION OF THE OWNER OF SAID PROPERTY; SAID PROPERTY LOCATED AT 8625 THOMAS DRIVE; ONE PARCEL ID 30462-000-000; AND PARCEL ID 30468-000-000; SAID PARCELS CONTAINING 0.568 ACRES MORE OR LESS; REDEFINING THE BOUNDARY LINES OF THE CITY: REPEALING ORDINANCES IN CONFLICT AND PROVIDING THAT THIS ORDINANCE SHALL TAKE EFFECT IMMEDIATELY UPON PASSAGE.

WHEREAS, Charlotte Newby, owner of real property voluntarily annexed into the City of Panama City Beach, Florida, and which property is contiguous to an unincorporated area of Bay County, Florida, has filed a petition praying that said real property, being more particularly described below, be excluded from this City, and

WHEREAS, the City Council of this City has determined that the petition bears the signatures of all the owners of the property in the area proposed to be excluded, and

WHEREAS, the Planning Board of the City of Panama City Beach, Florida, met on December 8, 2021, and voted 6-0 to approve the request.

WHEREAS, Notice of Voluntary Contraction for this property has been published in the Panama City News-Herald once a week for two (2) consecutive weeks prior to this date, the same being a newspaper of general circulation in this City, a copy of which notice is attached, incorporated and marked Exhibit B; and

WHEREAS, the City Council of this City finds that the subject property has no resident population and consists of 2 single parcels. The subject parcels are contiguous to unincorporated Bay County and exclusion of the subject parcels will not create an enclave of unincorporated territory within the boundaries of the City. The subject parcels are a parking area for a bar/lounge which is located within the Bay County boundaries and is now adjacent to the subject parcels. A hardship is created in the delivery of services such as police, fire, code enforcement and planning due to the fact that the bar/lounge and its parking area are divided by City and County boundaries. Therefore, the City Council finds that the subject parking area fails to meet the criteria of Section 171.043 for annexation by referendum.

NOW, THEREFORE, BE IT ENACTED BY THE PEOPLE OF THE CITY OF PANAMA CITY BEACH, FLORIDA:

Section 1. The following described lands in Bay County, Florida, are hereby excluded from the City of Panama City Beach, Florida, to wit,


- Section 2. The boundary lines of the City of Panama City Beach, Florida, are contracted and redefined to exclude therefrom said tract of land.
  - Section 3. A map of the area to be excluded is attached.
- Section 4. All ordinances or parts of ordinances in conflict herewith are repealed to the extent of such conflict.
  - Section 5. The appropriate officers and agents of the City are authorized and directed to modify and publish in electronic format changes to the City's Future

Land Use Map and Zoning Map within the Panama City Beach Comprehensive Growth Development Plan and Land Development Code respectively, to reflect the removal of this land from the City boundaries, unless a contrary ordinance is adopted within ninety (90) days following such publication.

Section 6. This ordinance shall take effect immediately upon passage.


