## **ADDENDUM NO. 5**

# PCB22-84 ITB Fire Tower

#### **Questions:**

- 1) We are unable to locate a modular component fire tower manufacturer that fabricates their components from new, never used containers. We have been told by all of the known manufacturers that all containers come from overseas and are shipped to the United States as shipping containers making them all Single Use containers. We cannot find a source for containers that are manufactured new for modular fire tower components. Please provide the basis of design so that we can comply with this requirement in our bid.
  - A. Section 13 34 24, Paragraph. #2.1A (previously amended in addendum #4) is hereby amended again to delete Alternate No. 4, and revising Base Bid requirements as follows:
    - "A. All containers used in the fabrication of training tower shall be single use ISO containers, commonly referred to as "One-Trip" Containers."
  - B. Section 00 03 00, Bid Schedule is amended as follows:
     Replace page 3 of spec section with new page 3(r2) deleting Bid Item No. 4 (see Attachment #1).
  - C. Section 01 15 00, is amended to delete paragraph 3.5 (BID ITEM NO.5) in its entirety.

- 2) During the mandatory pre-bid there was discussion about the owner providing crushed concrete aggregate for the contractor's use in constructing the project. The addendums did not address that issue. Please confirm whether or not the owner will provide crushed concrete aggregate for the contractor's use on the project.
  - A. Yes, crushed concrete, currently stockpiled just west of the project site, will be made available to the contractor for use on this project, at no charge. Material handling is the responsibility of the Contractor. Any material not used for this project shall be left in the stockpile and the pile area cleaned up at the end of the project.
- 3) Reference is made to 00 10 00-22 GENERAL CONDITIONS, 24.2 SUBCONTRACTING. "...The Contractor shall not award work to Subcontractor(s) in excess of fifty percent (50%) of the Contract Price, without prior written approval of the City."

Question: Given the specialty nature of this project, unless Prime offerors are Modular Fire Training Tower manufacturers, the total subcontracted work will undoubtedly exceed 50% of the Contract Price. Please confirm this requirement is not applicable to this project.

A. The requirement remains in effect, but the Owner acknowledges the training tower supplier may exceed the threshold and that component is excepted from this requirement.

#### Revisions:

- 4) Civil Sheet 2, Alternate 1 & 2 clarification to coordinate with architectural site plan and specifications.
  - A. Replace civil Sheet 2 in its entirety with new civil Sheet 2, Revision 1, dated 9/19/2022 (see Attachment #2)



- 5. By submitting this BID, the BIDDER and the BID BOND surety, are deemed to have stipulated and agreed that any and all claims, demands, actions or suits whatsoever, arising under this BID and/or BID BONDS, shall be subjected to the sole and exclusive jurisdiction and venue of the Circuit Court of Bay County, Florida. The BIDDER and BID BOND surety do agree, by submittal of this BID, that the sole and exclusive jurisdiction and venue in said forum is proper and appropriate since performance of the underlying contract to be awarded is to be accomplished within Bay County, Florida.
