A RESOLUTION OF THE CITY OF PANAMA CITY BEACH, FLORIDA, APPROVING THE PURCHASE OF A CRANE TRUCK FROM CUMBERLAND INTERNATIONAL TRUCKS, LLC, IN THE TOTAL AMOUNT OF \$174,299; AND AGREEING TO BE BOUND BY THE TERMS AND CONDITIONS OF THE FLORIDA SHERIFF'S ASSOCIATION CONTRACT GOVERNING THAT PURCHASE.

BE IT RESOLVED that the appropriate officers of the City are authorized to accept and deliver on behalf of the City that certain proposal between the City and Cumberland International Trucks, LLC, relating to the purchase of a Crane Truck for the Utilities Department in the amount of One Hundred Seventy-Four Thousand, Two Hundred Ninety-Nine Dollars (\$174,299.00) in substantially the form **attached** as Exhibit A and presented to the Council today, with such changes, insertions or omissions as may be approved by the City Manager.

AND BE IT FURTHER RESOLVED THAT by accepting the proposal referenced above, that the City agrees to be bound to the same terms and conditions as were obtained by the Florida Sheriff's Association, through an advertised, competitive bidding process, FSA22-VEH20.0 - Heavy Trucks and Buses, in the form **attached** as Exhibit B.

THIS RESOLUTION shall be effective immediately upon passage.
