Mayor Mark Sheldon called the July 13, 2023, regular meeting to order at 6:00 p.m.

PRESENTATIONS

Mayor Sheldon invited Dr. Jessica Graham, Executive Director of the St. Andrew and St. Joseph Bays Estuary Program, to the podium to provide an update on the program (copy of presentation attached).

PUBLIC COMMENTS - NON-AGENDA BUSINESS (LIMITED TO THREE MINUTES)

Mayor Sheldon opened the floor to non-agenda business public comments, limited to three minutes each.

- 1. <u>Jody Moore with The Beacon of Bay County Florida, on Facebook</u> Ms. Moore noted she lived on Amherst Street in Lynn Haven. Ms. Moore commented that she was here to speak on Item J2. Mayor Sheldon invited her to come back up at that time. Ms. Moore thanked Council for looking into preserving St. Andrews Bay.
- 2. <u>Frank Sewell</u> –Mr. Sewell stated he lived in the Hidden Pines neighborhood and was here on behalf of the Bay County Republican Executive Committee. Mr. Sewell suggested a potential charter change to have a run-off if a candidate does not receive 50% or more of the vote in an election for future elections.
- 3. <u>Scott Boatwright with Chairs to You Beach Service</u>. Mr. Boatwright commented that he was here to speak on Item J1. Mayor Sheldon invited him to come back up during that time.
- 4. <u>Peter Fischetti</u> –Mr. Fischetti stated he was here to speak on the CRA 4.2 Plan. Mr. Fischetti raised concerns about the study for the plan and whether certain areas were blighted or unblighted. Mr. Fischetti commented that one primary objective of the Plan was to enhance parking. Mr. Fischetti thinks the CRA Plan removes parking spacings from the right-of-way on Front Beach Road. Mr. Fischetti inquired if Council had purchased property for additional parking and restrooms, as stated in the Plan, and asked about the location(s) and the costs, if so. Mr. Fischetti commented on the trolley lanes on Front Beach Road and people using the trolley to go to work at the businesses on Front Beach Road.
- 5. <u>Burnie Thompson</u> Mr. Thompson echoed the previous gentleman's concerns. Mr. Thompson congratulated Mayor Sheldon on the success of Gulf Coast Jam. Mr. Thompson discussed his concerns about TDC sponsorship for businesses.

Mayor Sheldon called for additional public comments. Hearing and seeing none, Mayor Sheldon closed the public comment period.

CONSENT AGENDA

- *1. RESOLUTION NO. 23-195, A RESOLUTION OF THE CITY OF PANAMA CITY BEACH, FLORIDA, APPROVING CHANGE ORDER #7 TO THE CITY'S AGREEMENT WITH CWR CONTRACTING, INC., FOR THE FRONT BEACH ROAD SEGMENT 3 PROJECT TO INCREASE THE CONTRACT AMOUNT BY \$28,738.18 AND ADD FOUR DAYS FOR PERFORMANCE OF THE WORK.
- **2. REVISION OF THE MASTER AUDIT LIST TO REMOVE SURPLUS ITEMS.** These items are to be removed from the Master Audit List. Staff recommends approval. By approval of this matter in the Consent Agenda, the City Council makes a finding of surplus for these items and approves their removal from the Master Audit List.

Mayor Sheldon asked the Clerk to read the Consent Agenda. Mayor Sheldon noted the Consent Agenda was available to Council. Councilman Jarman moved to approve the Consent Agenda. Councilmember Coburn seconded the motion. Mayor Sheldon asked the Clerk to call the roll. The Consent Agenda was unanimously approved by a (5-0) roll call vote.

REGULAR AGENDA- DISCUSSION/ACTION ITEMS

ITEM 1. ORDINANCE NO. 1627, AMENDING CHAPTER 7 OF THE CITY'S CODE OF ORDINANCES RELATED TO BEACHES, BOATS, AND WATERWAYS, SECOND READING / PUBLIC HEARING.

Mayor Sheldon introduced City Attorney Cole Davis. Mr. Davis read Ordinance No. 1627 by title only. Mayor Sheldon opened the public hearing.

- 1. <u>Scott Boatwright with Chairs to You Beach Service</u>. Mr. Boatwright commented that he had been serving the residents on PCB for over 10 years. Mr. Boatwright commented he cannot deliver chairs and umbrellas to folks on the beach right now, including people on the beach who are in wheelchairs. Mr. Boatwright expressed his concern over requiring the upland owner's consent for beach chair services on or adjacent to their property. Mr. Boatwright stated he would rather deal with the City than an upland property owner and asked about the process for paperwork and compliance.
- 2. <u>Jordan Good with Surf and Sun Recreation</u> Mr. Good echoed the previous gentleman's concerns. Mr. Good noted his main concern was having to register with each individual upload owner for beach service. Mr. Good expressed concern with the suggested registration and enforcement process. Mr. Good recommended the City's process be set up like Walton County's model.
- 3. <u>Burnie Thompson</u> –Mr. Thompson expressed concern that residents and visitors would not be able to have umbrellas on the beach if this ordinance was passed.

Mayor Sheldon called for additional public comments. Hearing and seeing no comment, Mayor Sheldon closed the public hearing. Mayor Sheldon noted this item was available to Council and asked Attorney Davis to provide some clarification.

Attorney Davis explained that delivering beach umbrellas and chairs has always been prohibited, however, this ordinance: 1) now opens delivery up, 2) requires a permit with the City as part of the permit process and 3) requires permission from the upland owner, which is a legal requirement from the state's beach renourishment statue. Attorney Davis further explained under the current Code, beach service was only permitted if a vendor had a hut, however, this ordinance would allow a vendor to go forth without a hut.

Councilman Jarman further clarified that according to the renourishment statute, the upland owner still controlled the commercial rights of the beach, while recreation rights were open to the public. Attorney Davis concurred. Vice Mayor Casto clarified, with this ordinance, a family could still take an umbrella to the beach, nothing was banned. Mayor Sheldon concurred. Attorney Davis concurred and added the amendment allows the beach service to deliver the umbrella all the way down to the sand and place it for the customer. Mayor Sheldon noted this ordinance takes care of delivering the umbrella to the child in the wheelchair on the beach, as Mr. Boatwright previously expressed concern. Mayor Sheldon called for additional comments from Council. Councilmember Coburn asked that Council answer Mr. Good's question.

1. <u>Jordan Good with Surf and Sun Recreation</u> – Mr. Good expressed his appreciation that Council was opening delivery up within city limits. Discussion regarding one vendor per location took place. Mr. Good asked Council to amend the ordinance to allow for multiple vendors at one location.

Manager Whitman explained, right now, the ordinance was set up for one vendor per location. Mayor Sheldon asked Attorney Davis if multiple vendors could be allowed at one location. Attorney Davis noted that was at the pleasure of Council and would require some additional writing and a third reading.

Councilman Jarman explained the City was constrained by the property rights of the upland owner. Councilman Jarman added he felt that it was the business owner's responsibility to negotiate with the upload owner. Vice Mayor Casto and Mayor Sheldon concurred.

Councilman Chester noted what had been talked about this evening was single-family homes. Councilman Chester inquired as to what Bid-A-Wee would consist of. Attorney Davis explained the ordinance addressed that as well, the delivery service would need to collaborate and contract with the HOA, as the upland property owner.

Mayor Sheldon called for further comments from Council. Hearing and seeing none. Councilman Jarman moved to approve Ordinance No. 1627. Vice Mayor Casto seconded the motion. Mayor Sheldon called for further discussion. Hearing and seeing none, Mayor Sheldon asked the Clerk to call the roll. Ordinance No. 1627 was adopted by a unanimous (5-0) roll call vote.

ITEM 2. ORDINANCE NO. 1625, AMENDING CITY CODE CHAPTER 29 RELATED TO EMERGENCY MANAGEMENT, FIRST READING.

Mayor Sheldon introduced City Attorney Cole Davis. Mr. Davis read Ordinance No. 1625 by title only. Mayor Sheldon opened the public hearing.

- 1. <u>Jody Moore with The Beacon of Bay County Florida, on Facebook</u> Ms. Moore noted she lived in Lynn Haven. Ms. Moore commented that she shopped and visited the beach. Ms. Moore stated personal concerns about the scope and content of the ordinance.
- 2. <u>Molly Allen, Lullwater Resident</u>– Ms. Allen wished Cole a Happy Birthday. Ms. Allen read from a passage from the bible and raised her concerns about the scope and length of time within the ordinance. She mentioned personal issues she had with campers in the woods by her home.
- 3. <u>Burnie Thompson</u> Mr. Thompson thanked Council for addressing the previous agenda item, and admitted he was wrong. Mr. Thompson read a piece of Ordinance 1625 and expressed concern that the City Manager would have discretionary authority to detain people for 42 days.
- 4. <u>Gerry Parker with The Beacon of Bay County Florida</u> Ms. Parker noted that she also lived in Lynn Haven. Ms. Parker echoed the concerns of the other speakers and was concerned with constitutional compliance.

Mayor Sheldon called for additional comments from the public. Hearing and seeing none, Mayor Sheldon closed the public hearing. Mayor Sheldon noted this item was available to Council and asked Attorney Davis to comment.

Attorney Davis explained the 42-day provision in the ordinance was being codified pursuant to the Florida Statute that regulates emergency powers and would clarify the City Management's and Council's power in compliance with state law.

Vice Mayor Casto inquired if the ordinance was unconstitutional in his opinion. Attorney Davis stated no, not in his opinion. Vice Mayor Casto noted he had known Drew for a longtime and Drew would not abuse this. Vice Mayor Casto discussed Hurricane Michael and explained how the City lost all communication during and after the storm and further explained how Police were delivering notes back and forth to councilmembers. Vice Mayor Casto added this ordinance would give the City Manager the power to close washed out roads, call curfews, and would be a tool, if needed, that could be taken away.

Mayor Sheldon concurred and added that the Council looked at this a couple of years ago during a civil unrest. Mayor Sheldon noted he absolutely had no problem giving the City Manager the authority to do this.

Councilman Chester inquired if there was a significance with the 42-days. Attorney Davis explained the City Manager's power were limited to 72 hours, and that if the emergency needed to be extended beyond 72 hours, Council would need to meet within 72 hours. Attorney Davis added City Council's authority would be limited to 42-days, by state statute.

Councilman Jarman clarified the changes from the original ordinance added weather and codification. Attorney Davis concurred. Councilman Jarman further clarified that people on the beach were looking for some quick action to the civil unrest last year. Councilman Jarman discussed Council's ability to convene a meeting at any time to change the action taken by the City Manager. Councilman Jarman noted he was comfortable moving forward, especially with Drew's knowledge in law enforcement. Councilman Jarman added that the authority could be taken away from the City Manager, depending upon the City Manager. Mayor Sheldon reminded everyone that the City Manager was accountable to the City Council.

Councilmember Coburn noted that she understood the need during civil unrest to act swiftly, however, she was uncomfortable with the ordinance and felt that it was over-reaching. Councilmember Coburn added that she felt the ordinance chipped away at personal freedoms and was not supporting it the way it was written today.

Councilman Jarman discussed a terrorist attack as example. Councilmember Coburn noted that the City had time to plan for a storm to come into the City. Councilman Jarman asked the City Manager to give an example of a weather-related issue when this would be used.

Manager Whitman explained in order for the City to receive any kind of disaster pay for employees, a state of emergency needed to be called. Manager Whitman further explained the process of being reimbursed by the Federal government. Manager Whitman discussed Hurricane Michael and the Council possibly taking two days or more to convene a meeting to call an emergency. Manager Whitman added he talked with Council about this last April. Manager Whitman clarified further that this ordinance would get our employees paid properly and immediately. Manager Whitman added if Council needed to leave the beach for your families, he would remain and make those decisions and move forward. Manager Whitman further explained if something happened to the Mayor, he needed three members to call an emergency, or one Mayor. Manager Whitman added he would like to put this in place to protect the community and the City's employees.

Mayor Sheldon clarified even with a weather incident, the Council cannot create a state of emergency until it happens so if the Council cannot get together because of personal emergencies, the team could still get emergency pay prior to Council meeting. The Mayor and the City Manager further explained FEMA not reimbursing the City retroactively, employee disaster/hazard pay and how an emergency must be called when the emergency happens, not before, not until a Hurricane hits land.

Vice Mayor Casto further discussed how he was unable to be reached during Hurricane Michael because of his personal emergency on the east end of the beach. Vice Mayor Casto further explained how he was unable to make the emergency meeting, after the Police had finally tracked him down. Vice Mayor Casto added he trusted Drew to make these decisions. Vice Mayor Casto moved to approve Ordinance No. 1625. Councilman Jarman seconded the motion. Mayor Sheldon called for further discussion. Hearing and seeing none, Mayor Sheldon asked the Clerk to call the roll. Ordinance No. 1625 was adopted by a (4-1) roll call vote.

Councilman Chester moved to approve Resolution No. 23-196. Councilman Jarman seconded the motion. Mayor Sheldon called for further discussion. Hearing and seeing none, Mayor Sheldon asked the Clerk to call the roll. Resolution No. 23-196 was adopted by a unanimous (5-0) roll call vote.

ITEM 4. RESOLUTION NO. 23-197, APPROVING AN AGREEMENT FOR RESIDENTIAL AND COMMERCIAL PLANS REVIEW AND BUILDING INSPECTION SERVICES.

Mayor Sheldon introduced City Attorney Cole Davis. Mr. Davis read Resolution No. 23-197 by title only. Mayor Sheldon invited public comment on Item #4. Hearing and seeing no comment, Mayor Sheldon closed the public comment period. Mayor Sheldon invited Director Leonard to the podium.

Director Leonard reported C.A.P. Government, Inc. was the current provider of residential and commercial plans review and building inspection services, with a contract that expires on September 30, 2023. Director Leonard reported further that C.A.P was the only responsive bidder, and their rates would remain unchanged. Director Leonard reported Staff recommended approval. Mayor Sheldon noted this item was available to Council.

Councilman Chester noted he understood the rate came in under budget. Director Leonard concurred and noted it was an \$80,000 per year savings for the City.

Councilman Chester moved to approve Resolution No. 23-197. Councilman Jarman seconded the motion. Mayor Sheldon called for further discussion. Hearing and seeing none, Mayor Sheldon asked the Clerk to call the roll. Resolution No. 23-197 was adopted by a unanimous (5-0) roll call vote.

ITEM 8. DISCUSSION / ACTION ITEM, APPOINTMENTS TO THE AUDIT COMMITTEE.

Mayor Sheldon invited public comment on Item #8. Hearing and seeing no comment, Mayor Sheldon closed the public comment period. Mayor Sheldon reported the open seats were advertised, however, there were no takers, no applications were received. Assistant City Manager White concurred and explained the purpose of the Committee and the general accounting practices/qualifications needed to serve on the Committee. Mayor Sheldon reported the Committee needed two more members. Mayor Sheldon recommended keeping this item open while Councilmembers searched for new members. Mayor Sheldon noted this item was available to Council. Council members agreed by unanimous consent to keep this item open and continue to search for two qualified applicants. Voting was not called for.

<u>CITY MANAGER REPORT</u> — Manager Whitman wished Mr. Davis a happy birthday. Manager Whitman thanked Mel, Terri and Lauryn from the Building Department for assisting him with a presentation at CPAR. Manager Whitman added they did an amazing job, like they always do. Manager Whitman congratulated Wyatt with the Public Works Department on passing his professional engineers test, he was now a Professional Engineer. Manager Whitman addressed Ms. Allen and explained that if anyone from the Police Department ever laughed at her, he and the Chief would not tolerate it. Manager Whitman asked for that person's name so they could look into it. Manager Whitman explained that he had talked with Ms. Allen several times and he had Police Officers, with the Canine Unit, walk the trails in the Lullwater area.

CITY ATTORNEY REPORT – Mr. Davis thanked everyone for their birthday wishes.

COUNCIL COMMENTS - Mayor Sheldon invited comments from Council. Councilman Jarman concurred with Manager Whitman and asked Ms. Allen to please report something like that, if it ever happens. Councilman Jarman, as a member of the TPO, asked for opinions on the 6-laning of Back Beach Road. Vice Mayor Casto noted that it was past due, and he was very happy to see the State putting money toward it. Mayor Sheldon concurred and thanked the members of the TPO, Secretary Gainer and the Governor put the project on their lists. Councilman Chester concurred and noted it should have been done in 2004 – 2005, but it would be a great project. Councilman Jarman asked Councilmembers to get with him if and when they had any questions. Councilman Jarman reported the construction timeline should be about 2-year.

Mayor Sheldon noted yesterday was Councilman Chester's birthday and wished him a happy birthday. Mayor Sheldon added he would have answered Mr. Thompson's questions, however, he had exited the meeting.

With nothing further, Mayor Sheldon adjourned the meeting by unanimous consent at 7:18 p.m.
