BE IT RESOLVED that:

- 1. The appropriate officers of the City are authorized to execute and deliver on behalf of the City that certain proposal between the City and Fisher Scientific Company, LLC relating to the purchase of self-contained breathing apparatus equipment in the amount of Fifty Seven Thousand One Hundred Twenty-Six Dollars and Eighty-Three Cents (\$57,126.83) in substantially the form attached as Exhibit A and presented to the Council today, with such changes, insertions or omissions as may be approved by the City Manager and whose execution shall be conclusive evidence of such approval.
- 2. By accepting the proposal referenced above, the City agrees to be bound to the same terms and conditions as were obtained by Orange County, Florida, Fire Rescue, through an advertised, competitive bidding process, Contract No. Y22-1053B in the form **attached** as Exhibit B.
