TASK ORDER 2024-02

This Task Order is for the purpose of Dewberry Engineers, Inc. as the Engineer to provide professional services for the Community Redevelopment Plan Project Segment 4.2 Front Beach Road (East of Hills Road to Hutchison Boulevard) to the City of Panama City Beach (City) acting by and through its Council. This scope of services is to provide design, analysis, plans preparation, and coordination services specific to requested property acquisitions, roadway revisions, street lighting revisions, and utility coordination. The scope of services for the retaining wall surveying, testing, design, and permitting is specific to the requested retaining wall in the Bid A Wee Beach area of the project.

SCOPE OF SERVICES AND FEE SCHEDULE

1.0 PROJECT MANAGEMENT & COORDINATION - \$28,100

Due to unforeseen project delays, additional project management & coordination is being requested for the CRA Segment 4.2 project

- 1.2. Coordination with design team and sub consultants throughout the project
- 1.3. Provide monthly updates to City staff to discuss milestone reviews and project updates
- 1.4. Provide coordination and assist in public outreach with City staff throughout the design phase

2.0 PROPERTY ACQUISTION COORDINTATION - \$55,579

- 2.1. Coordination with property acquisition team and sub consultants throughout the project.
- 2.2. Parcel Sketch of Descriptions

3.0 SURVEY - \$12,700

3.1. Dewberry shall perform all office and field work for the purpose of performing a Boundary and Topographic Survey of Bay County Parcel ID No. 34498-000-000 and 33768-001-000 to meet the requirements of the FDEP - Rules and Procedures for Coastal Construction and Excavation, Chapter 62B-33.0081.

4.0 STRUCTURAL ENGINEERING - \$52,923

4.1. Work to be performed by Dewberry includes design of 2,150 linear feet retaining wall (6' max. exposed height) and design of sidewalks that incorporate a retaining wall (under 2' exposed height).

5.0 SEAWALL COASTAL DESIGN AND PERMITTING SUPPORT - \$16,278

- 7.1. Dewberry will perform additional Roadway Analysis for the incorporation of retaining walls through narrow right of way corridors and along the Bid A Wee Beach area.
- 7.2. Dewberry will modify Roadway Plans for the incorporation of retaining walls through narrow right of way corridors and along the Bid A Wee Beach area.
