ORDINANCE NO. 1341

AN ORDINANCE OF THE CITY OF PANAMA CITY BEACH, FLORIDA, AMENDING ORDINANCE NO. 1143, KNOWN AS THE 2009 AMENDED AND RESTATED PANAMA CITY BEACH COMPREHENSIVE GROWTH DEVELOPMENT PLAN; UPDATING HISTORICAL AND PROJECTED WATER USAGE TABLES APPROVED IN THE CITY'S 2015 WATER SUPPLY FACILITIES WORKPLAN; AMENDING POLICY 3.7 TO PROVIDE FOR A RATE STUDY TO BE UNDERTAKEN IN 2016; REPEALING ALL ORDINANCES IN CONFLICT TO THE EXTENT OF SUCH CONFLICT AND PROVIDING THAT THIS LAW SHALL TAKE EFFECT AS PROVIDED BY LAW.

WHEREAS, the Panama City Beach City Council approved Ordinance No. 1143 ("the 2009 Amended and Restated Panama City Beach Comprehensive Growth Development Plan") on December 10, 2009; and

WHEREAS, the Northwest Florida Water Management District approved the Region III 2014 Regional Water Supply Plan Updated in March 2014; and

WHEREAS, the Panama City Beach Planning Board reviewed the City's February 2015 Water Supply Facilities Work Plan, conducted a public hearing on March 9, 2015, and recommended approval; and

WHEREAS, on March 26, 2015 the City Council conducted a properly noticed transmittal hearing as required by Section 163.3184, Florida Statutes; and

WHEREAS, on July 9, 2015 the City Council conducted a properly noticed adoption hearing as required by Section 163.3184, and adopted this Ordinance during the second hearing; and

WHEREAS, all conditions required for the enactment of this Ordinance to amend the City of Panama City Beach Comprehensive Growth Development Plan have been met.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PANAMA CITY BEACH:

SECTION 1. From and after the effective date of this ordinance, the Tables 6 and 7 of the Potable Water Sub-Element contained in Current Conditions, Section 7 of the City's Comprehensive Plan related to Sanitary Sewer, Solid Waste, Stormwater Drainage, Potable Ord. 1341

Water and Aquifer Recharge, is amended to read as follows (new text **bold and underlined**, deleted text struckthrough):

SECTION 7

SECTION 2. From and after the effective date of this ordinance, the Policy 3.7 of the Potable Water Sub-Element contained in Section 7 of the City's Comprehensive Plan related to Sanitary Sewer, Solid Waste, Stormwater Drainage, Potable Water and Aquifer Recharge, is amended to read as follows (new text **bold and underlined**, deleted text **struckthrough**):

SECTION 7

SANITARY SEWER, SOLID WASTE, STORMWATER DRAINAGE, POTABLE WATER AND AQUIFER RECHARGE

- 2. UTILITIES SUB-ELEMENTS
- D. POTABLE WATER SUB-ELEMENT

GOALS, OBJECTIVES AND POLICIES

. . .

OBJECTIVE 3: Upon adoption of this Plan, require use of water conservation measures and techniques.

POLICY 3.1: The City shall enforce the use of water conservation plumbing fixtures and equipment, as required in 553.14 Fla.Stat.

<u>POLICY 3.2</u>: The City shall undertake emergency measures specified in the <u>Northwest Florida Water Management District Water Shortage Plan</u> in the event of a potable water emergency.

<u>POLICY 3.3:</u> The City shall pursue additional revenue sources to fund water supply and facility projects.

<u>POLICY 3.4:</u> The City shall regularly review the potable water impact fees to ensure they are adequate to fund system improvements for new development, redevelopment, and to maintain and repair the existing system.

<u>POLICY 3.5:</u> The City will continue to examine the extent to which interconnectivity is possible with water facilities of other local jurisdictions.

POLICY 3.6: The City will coordinate with the Northwest Florida Water Ord. 1341

Management District and Bay County to protect the water quality of Deer Point Lake and any new alternative water supply source.

POLICY 3.7: The City will conduct a rate study in 2016 2011 and upon its conclusion will consider rate structures that improve water conservation such as: full cost rate structures, inclining block rates, and seasonal rates.

<u>POLICY 3.8:</u> The City will continue to encourage water conservation through land development regulations by requiring the preservation and use of native vegetation, when possible, as well as encouraging xeriscaping.

SECTION 3. All ordinances or parts of ordinances in conflict herewith are repealed to the extent of such conflict.

SECTION 4. This Ordinance shall take effect as provided by law.
