The appropriate officers of the City are authorized but not required to accept and deliver on behalf of the City that certain Agreement between the City and Bay Dodge, relating to the purchase of 3 Dodge Chargers in in the basic amount of Seventy Four Thousand Seven Hundred Dollars (\$74,700), in substantially the form of the quote attached and presented as Exhibit B to the Council today, with such changes, insertions or omissions as may be approved by the City Manager and whose execution shall be conclusive evidence of such approval.
